Commission's consideration of Summarily Suspending Ant Brian Exterminating's business license, and Mr. Oldham's qualifying party and applicator licenses. Pursuant to A.R.S. § 32-2329, the commission may summarily suspend, without a formal hearing, any license issued by the commission if the commission deems it necessary to protect the health, safety and welfare of the public. The Commission has information that Mr. Oldham, owner of Ant Brian Exterminating, and qualifying party and applicator licensee may have committed theft from and burglary of one or more of his customers' homes.

III. Jordan P. Dietz, Applicator License Applicant, Case 2006-006
