II. Call to the public

Ken Frederick from Arizona Pest Professional Association (AzPPO) spoke to remind everyone of AzPPO's Rules Committee. A. Bob's Bug Biz (BL) Robert Deutsch (QP) – Case 2006 - 022

No appearances. Ms. Gervase explained that Mr. Deutsch was present at last month's meeting, and all TARFs have been submitted.

MOTION: *To accept the proposed resolution regarding the Business License, and if the Consent Agreement is not executed by the deadline stated in the Consent Agreement transmittal letter to send the case to the Office of Administrative Hearings; further, to dismiss the case against the QP license, by Commissioner Black.

B. No Problem Pest & Termite Control (BL) / Donald Jay Waller (APP/QP) – Case No. 2006 – 037

No appearances.

MOTION: *To accept the proposed resolution regarding the Business License, and if the Consent Agreement is not executed by the deadline stated in the Consent Agreement transmittal letter to send the case to the Office of Administrative Hearings; further, to dismiss the case against the QP license and Applicator license, by Commissioner Black.
Seconded by Commissioner DeVere.*

C. A Bee C Beekeepers & Exterminators (BL) / Nikola Potkonjak (APP) – Case 2006 – 035

No appearances. Commissioner Burns expressed concern that Mr. Potkonjak had financial gains from being a QP for another company while still doing work for this company, and asked Mr. Craig if this was the case. Mr. Craig explained that the other company's original owner and QP had died, and that Mr. Potkonjak had stepped in as QP for the business in order to help the widow. Commissioner Burns asked Mr. Craig the status of the business insurance for A Bee C Beekeepers. Mr. Craig indicated that the insurance was still intact at the time of the work that Mr. Potkonjak performed under this company while his QP was active for another company.

MOTION: *To accept the proposed resolution, and if the Consent Agreement is not executed by the deadline stated in the Consent Agreement transmittal letter to send the case to the Office of Administrative Hearings, by Commissioner DeVere.
Seconded by Commissioner Black.*

VOTE: 5 – 1 *Motion carried. (Commissioner Burns opposed).*

D. John Reding (APP) – Case 2006 - 050

No appearances. Mr. Craig explained that Mr. Reding lives in Prescott, and had requested the Settlement Conference be held via telephone due to the distance, and it is likely that this is the reason Mr. Reding is not appearing today.

MOTION: *To accept the proposed resolution, and if the Consent Agreement is not executed by the deadline stated in the Consent Agreement transmittal letter to send the case to the Office of Administrative Hearings, by Commissioner Black.
Seconded by Commissioner DeVere.*

DISCUSSION:

Commissioner Burns said since the same individual completed the home inspection and WDIIR, he wondered whether it is still a violation to not note something required on the WDIIR if it's noted on the home inspection report. He feels that this is a trend in the industry, and that the home inspection can be added as an addendum to the WDIIR. Commissioner Black was of the opinion that in this case, the document was not an addendum; it was the home inspection report. He gave his opinion that these two documents should be separate and it is a violation to not note something required on the WDIIR. Commissioner Runbeck agreed it is a violation.

Mr. Craig explained that the SPCC does not have jurisdiction over the home inspection report, but does have jurisdiction over the WDIIR, which in this case, was not completed.

VOTE: 5 - 1 Motion carried. (Commissioner Burns opposed).

E. Johnny Camilo (APP) – Case No. 2006-063

Mr. Camilo was present. He advised the Commission that he acknowledges he had made a mistake, has ceased any Pest Control activity. He stated that he believed that he had an arrangement with the previous owner (Bugsy) to service the 14 clients in question. These services occurred November 4-14, 2006. Mr. Camilo further stated that a language barrier might have prevented him from fully understanding the terms of his "arrangement" with Bugsy.

Commissioner Burns asked if Mr. Camilo had paid any royalties to the business. Mr. Camilo reported that he had not.

Mr. Craig advised the Commission that Mr. Camilo had asked for an extension in order to pay the fine over a period of six months.

MOTION: To modify the proposed resolution by decreasing the fine to \$300, to be paid over a period of three months, and if the Consent Agreement is not executed by the deadline stated in the Consent Agreement transmittal letter to send the case to the Office of Administrative Hearings, by Commissioner Baker.
Seconded by Commissioner Black.

DISCUSSION:

Mr. Nathan Watters, owner of Cummings Pest Control requested an opportunity to speak. Mr. Watters stated that Mr. Camilo displayed a blatant disregard for the law, and should not be allowed to continue to participate in the Pest Control Industry. He believes Mr. Camilo stole his customers with full knowledge of what he was doing.

Commissioner Burns agreed with Mr. Watters. He suggested that the matter be sent back to settlement conference, and that Mr. Camilo reimburse Mr. Watters for the revenue obtained from the customers. Commissioner Burns indicated he would entertain a reduced fine should the licensee surrender his license. Ms. Cornelius advised the Commission that reimbursement would be a civil matter, and that the Commission consider returning the matter to staff to work out a revised settlement agreement consistent with previous Commission actions.

Commissioner Baker withdrew his motion. Commissioner Black withdrew the Second.

MOTION: To modify the proposed resolution by increasing the period of time for payment of the original fine to six months and if the Consent Agreement is not executed by the deadline stated in the Consent Agreement transmittal letter to send the case to the Office of Administrative Hearings, by Commissioner DeVere. Seconded by Commissioner Baker.

VOTE 2 – 4 Motion fails (Commissioner Runbeck- Yes, Commissioner DeVere- Yes, Commissioner Black- No, Commissioner Baker- No, Commissioner Burns- No, Commissioner O’Neal- No).

Commissioner Baker suggested that it would be best to send the matter back to staff for an additional settlement conference to discuss all disciplinary options. Commissioner Burns stated that if the Respondent was willing to surrender his license, he would accept a reduced civil penalty. Ms. Cornelius asked if the Commission would consider some period of suspension. She clarified that the Commission is the complainant, not Cummings Pest. But, Cummings interests are protected by the Commission’s actions. Also, the Respondent is entitled to due process.

Ms. Cornelius reminded the Commission that the licensee should be aware that he would not be able to reapply for five years if he surrendered his license. She suggested that the Commission could send the matter back to staff to ensure that the licensee has an opportunity to consider his options, and to ensure that any additional terms of settlement are consistent with the Commission’s previous actions.

MOTION: To return the matter to staff for settlement conference, to modify the resolution based on stated factors and rationale, by Commissioner O’Neal. Seconded by Commissioner Black.

DISCUSSION:

Commissioner Black said that if Cummings is made whole and the Respondent has some suspension, he would agree to a resolution without a license revocation.

Commissioner Burns agreed. Commissioner Runbeck clarified that the Commission has no authority to order restitution, but if he voluntarily pays Cummings, that would be a mitigating factor.

VOTE 6 – 0 Motion carried.

F. Cherokee Exterminating (BL) / George Bryce (QP) / David Piper (APP) - Case 2006-030

Scott Richardson appeared for his client, David Piper. Mr. Craig reported that the settlement conference had been successfully held. Mr. Richardson reported that his client agreed to the terms of the settlement conference.

MOTION: To accept the proposed resolution and if the Consent Agreement is not executed by the deadline stated in the Consent Agreement transmittal letter to send the case to the Office of Administrative Hearings, by Commissioner Black.
Seconded by Commissioner DeVere.
